Page 8, Section 1.4 – Changes to Benefits and Costs for Medical Services	Omitted	Medicare Part B Prescription Drugs: You pay 20% of the total cost for Medicare Part B chemotherapy drugs and other Part B drugs. Effective 4/1/2023, certain rebatable drugs may be subject to a lower coinsurance.	Effective 4/1/2023, you may pay less than 20% coinsurance for certain Part B rebatable drugs.

Page 8, Section 1.4 – Changes to Benefits and Costs for Medical Services	Omitted	Insulin furnished through an item of durable medical equipment (DME): Effective 7/1/2023, you will not pay more than \$35 for a onemonth supply of insulin furnished through an item of DME, even if you have not paid your deductible.	Effective 7/1/2023, there will be a \$35 cap for a one-month supply of insulin furnished through an item of DME, even if you have not paid your deductible.
