Denver Health Medical Plan (DHMP) Healthcare Effectiveness Data and Information Set (HEDIS) is a quality tool used by more than 90 percent of U.S. health plans to measure performance on important dimensions of care and service. HEDIS includes more than 90 measures across six domains of care. Because so many plans collect HEDIS data and the measures are so specifically defined, HEDIS makes it possible to compare the performance of health plans on an “apples-to- apples” basis. Health plans also use HEDIS results to see where they need to focus their improvement efforts. HEDIS measures address a broad range of important health issues, such as:

- » Breast Cancer Screening
- » Controlling High Blood Pressure
- » Colorectal Cancer Screening
- » Diabetes Management
