COMMERCIAL SELF-FUNDED (DHHA EMPLOYEE PLANS)

Freestyle Libre products are preferred and are on Tier 2

» Allows up to 100-day supplies

Freestyle Libre 2 Plus has been added to the formulary (freestyleprovider.abbott/us-en/insulin-pump-compatibility.html) and is compatible with:

- » T:slim X2 insulin pump and Tandem t:connect mobile app
- » Omnipod 5 Automated Insulin Delivery System

Freestyle Libre 3 Plus has been added to the formulary and is compatible with:

» Beta Bionics iLet Bionic Pancreas

Dexcom G6 and G7 systems are non-preferred and are on Tier 4

- » Dexcom G6 and G7 Sensors are available as a 90-day supply; members will be charged 3 copays
- » Dexcom G7 has a current shortage with anticipated recovery on 3/31/2025
- » Dexcom G7 will officially be on the formulary 4/1/2025

For members 21 years of age and older:

» Continuous Glucose Monitors are a wrap-around benefit that is managed directly through the Colorado Department of Health Care Policy and Financing (HCPF). For Early, Periodic, Screening, Diagnostic and Treatment (EPSDT) members less than 21 years of age:

- » Freestyle Libre products are preferred and are on Tier 1
- » Freestyle Libre 2 Plus has been added to the formulary (https://www.freestyleprovider.abbott/us-en/insulin-pump-compatibility.html) and is compatible with:
 - T:slim X2 insulin pump and Tandem t:connect mobile app
 - Omnipod 5 Automated Insulin Delivery System
- » Freestyle Libre 3 Plus has been added to the formulary and is compatible with:
 - Beta Bionics iLet Bionic Pancreas
- » Dexcom G6 and G7 systems are non-preferred and are on Tier 2
 - Dexcom G7 has a current shortage with anticipated recovery on 3/31/2025
 - Dexcom G7 will officially be on the formulary 4/1/2025
